Other Fees and Charges

- A non-refundable FAI surcharge of \$210.00 will be assessed each FAI record claim and Circumnavigator Diploma application.
- Deluxe unmounted NAA certificate (11" w x 14" h) or FAI diploma (approx. 13¾" w x 10½" h) - \$45.00 each.
- Mounting of deluxe certificate or diploma on hardwood plaque (12½" x 15½") - add \$50.00 each.
- Standard unmounted NAA certificate or FAI diploma (both 8½" w x 11" h) - \$25.00 each.
- Mounting of standard certificate or diploma in simulated wood plaque (10½" x 13") - add \$35.00 each.
- GNSS Flight Recorder rental - \$495.00 per use (max. 5 consecutive days).
- Appeals to Contest & Records Board - deposit equal to registration fee.
- When a member of the Contest & Records Board is required to be present to oversee a record attempt, there will be a minimum fee of \$395.00 per day, plus expenses. Additional charges may apply.

¹ For record tasks not sanctioned in advance of the attempt, this fee is due at the time the record is claimed.
² Fees for "second and each additional" records are only applicable where such additional records are set on the same flight or within 30 days thereof.
³ There is an additional registration charge of \$15 for each flight leg/control point where the number of such legs/control points exceeds two on a given flight.
⁴ This fee includes a \$150.00 non-refundable processing fee.
⁵ This fee applies to extra records of identical performance.
